Distance: 8 kilometers (separate races men and women)

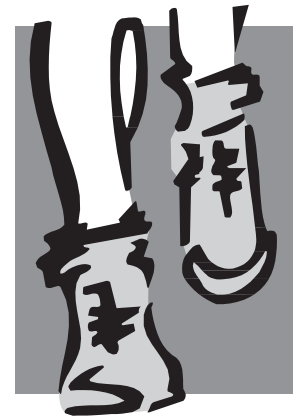
Course Description: This is a 3 loop course up Moon Hill and over several jumps and on dirt roads. Spectator friendly.
